# Inside Delhi's Civic Showdown MCD ELECTIONS 2025 & THE RISE OF A NEW POWER BLOC

A clean neighbourhood, functional schools for your children, reliable, timely, and smooth everyday commute, all this is determined by one governing body – The Municipal Corporation of Delhi (MCD). Its effectiveness or lack thereof directly affects the entire territory. MCD holds unparalleled significance in the everyday governance of India's capital. Responsible for civic services like, overseeing sanitation, public health, primary education, road maintenance, and licensing of markets and shops, the MCD's operations directly affect over 30 million residents daily.

In a city as sprawling and diverse as Delhi, the MCD acts as the frontline of public service. While state and central governments handle policy and law enforcement, it is the MCD that manages the potholes, garbage pickup, school upgrades, and water drainage. This makes its leadership pivotal in influencing both voter satisfaction and long-term urban development. As such, the 2025 MCD elections were more than administrative – they were a mirror reflecting Delhi's political future.

The battle for Delhi's civic heart is no longer just about sanitation or streetlights, it's a mirror to the capital's shifting political soul.

#### Behind the Turmoil: High Stakes in the Capital

Delhi's 2025 MCD elections unveiled under the shadow of the recent Assembly elections. It was a turbulent political season, filled with loud campaigns, ongoing bickering between political groups, and new entrants.

The BJP, encouraged by its success in the Delhi Assembly elections, found the MCD elections as a means to unify power at the civic level. The Aam Aadmi Party (AAP), bruised and battling internal divisions, chose an unconventional route, that is boycotting the mayoral poll entirely. This move surprised many and drew sharp criticism from opposition leaders and even some former allies. Whether the decision was a masterstroke or a miserable act of cowardice is upto public judgement.

Adding to the drama was the unexpected rise of the Indraprastha Vikas Party (IVP), formed by 16 rebel AAP councillors. This new party promised a new strategy, centered on local issues and community-driven development. IVP claims that the AAP had lost touch with grassroot governance.

#### Understanding the MCD: Pillar of Urban Governance

The Municipal Corporation of Delhi is one of the largest municipal bodies in the world. Reunified in 2022, it replaced the previous trifurcated structure of North, South, and East Delhi Municipal Corporations. Today, the unified MCD operates across 12 administrative zones with 250 elected councillors.

Its scope of work includes:


- Maintenance of over 1,700 primary schools
- Operation of more than 600 healthcare units
- Garbage collection and sanitation across over 11 million
- Licensing of street vendors and hawkers
- Management of over 250 parks and public grounds

In a megacity like Delhi, where civic problems can spark public outrage overnight, the MCD's performance has a direct bearing on political stability and voter confidence. Control over the MCD often sets the tone for Assembly and even Parliamentary outcomes.

#### **AAP's Reign and Retreat**

When AAP took control of the MCD in 2022, it was seen as a historic moment. For the first time, the same party controlled both the state government and the civic body. promised smoother coordination, implementation of projects, and reduced bureaucratic tensions.

Initially, AAP launched several campaigns—anti-dengue drives, school modernization efforts, and increased transparency in civic tenders.



However, by 2024, the cracks had begun to show. Uncollected garbage piles, teacher absenteeism, irregular audits, and allegations of favoritism in ward-level contracts started surfacing. Internal dissatisfaction grew, especially among councillors who felt sidelined by central decision-making.

Facing electoral backlash and criticism from civil society groups, AAP's leadership struggled to manage both narrative and morale. The final straw was the defection of 16 councillors, who would go on to form IVP. Rather than fight a losing battle, AAP opted to boycott the mayoral election altogether—a move some call principled, others say was an admission of defeat.

#### The Mayoral Verdict: BJP's Triumph

With AAP absent, BJP capitalized on the moment. Raja Iqbal Singh, a senior BJP leader and seasoned civic administrator, won the mayoral contest with a decisive 133 out of 142 votes. His deputy, Jai Bhagwan Yadav, also won unopposed.

The voting session, held amid tight security, saw Congress's presence fade into near-irrelevance. Holding just eight seats, the party could neither influence the outcome nor shape the post-election narrative.

Raja Iqbal Singh's victory speech emphasized civic pride, corruption-free administration, and a renewed vision for Delhi. He Declared:

e are not here for blame games. e are here to clean, build, and empower.

The BJP now had a golden opportunity to implement their agenda without the kind of pushback AAP once faced from a hostile civic body.

#### The Rise of IVP: Delhi's Third Force?

The Indraprastha Vikas Party (IVP) is perhaps the most intriguing outcome of this political upheaval. Launched by 16 former AAP councillors in early 2025, IVP claims to be a 'people-first, grassroots-driven' alternative to the capital's increasingly centralized governance.

#### Their manifesto includes:


- Decentralized budgeting at ward level
- Mandatory monthly town halls with residents
- Independent civic audits every quarter
- Promotion of community-based sanitation programs

Though still small with 13 seats, IVP has gained public attention, especially in South and Outer Delhi wards. Its leaders maintain that the party will support any initiative, regardless of party origin, that prioritizes local welfare. Political analysts believe that IVP could play a kingmaker role in future civic decisions and possibly influence Assembly politics by 2027.

#### MCD 2025: Party-wise Seat Distribution (Post Mayoral Election)





#### The BJP's Civic Gameplan

With full control of the mayor's office and strong political momentum, the BJP has laid out an ambitious 100-day action plan for Delhi.

#### The key areas of focus include:

**Health:** Opening 50 civic clinics with telemedicine facilities and free diagnostics.

**Education:** Digital smart boards in 300 municipal schools and hiring of 2,000 contractual teachers.

**Sanitation:** Setting up ward-level composting plants and improving garbage segregation rates.

**Public Transport:** Integration of MCD parking with Delhi Metro and launch of electric e-rickshaw stands.

**Environment:** Planting of 1 million saplings under the 'Green Delhi 2.0' initiative.

The BJP leadership has promised to maintain close coordination with the Delhi state government, which it now controls, as well as with the Central government, ensuring faster funding approvals and project clearances.

Operation Sindoor against terrorism is the new normal...

## OPERATION SINDOOR: INDIA'S PRECISION STRIKE AGAINST CROSS-BORDER TERRORISM

A bold, intelligence-led retaliation that redefined India's counter-terror strategy

On May 7, 2025, India launched a decisive military response named 'Operation Sindoor'—a strategic and precision-driven strike against cross-border terrorism. The operation came in the aftermath of the horrific Pahalgam terrorist attack and marks a significant evolution in India's counter-terrorism doctrine. Combining advanced warfare technology, comprehensive intelligence, and flawless execution, Operation Sindoor exemplifies India's unwavering stance on national security and justice.

In the pre-dawn hours of May 7, 2025, Indian Air Force Rafale fighter jets took off from bases in Rajasthan, their afterburners lighting up the desert sky as they flew west toward the Line of Control. In less than forty minutes those same aircraft fired the first salvo of SCALP cruise missiles and marked the beginning of Operation Sin door, a coordinated tri-service offensive designed to dismantle Pakistan-based terrorist infrastructures responsible for the

Pahalgam Terror Attack.

The strike was a decisive and strategic masterstroke, but it also unveiled a larger message: the rise of a new Indian security doctrine that blends surgical precision with political will. From the South Block briefing rooms in New Delhi to the corridors of think-tanks in Washington, the message was explicit 'India no longer waits to absorb punishment; it acts to prevent the next attack'.

## The Pehalgam Terror Attack

In the Anantnag district of the Kashmir valley, 5-7 km from Pahalgam nestled the Baisaran meadows. A spine-chilling incident befell on April 22 that will forever be etched in national memory as a day of unimaginable horror. In what was meant to be a joyful vacation, honeymoon, or peaceful retreat, 26 innocent Indian tourists including a Nepali national were brutally murdered in a terrorist attack in Pahalgam. Innocent civilians were gunned down at close range by suspected operatives of Lashkar-e-Taiba (LeT), marking the deadliest act of terror on Indian civilians since the 2008 Mumbai attacks.

The terrorists carried out an act of brutality that defied the most basic principles of humanity. Men were forcibly separated from their families and interrogated about their religious identity. Those who did not identify as Muslim were executed on the spot—murdered in cold blood before the eyes of their loved ones.

Intelligence agencies, including RAW and NTRO, swiftly intercepted communication intercepts, analyzed social media, and collated eyewitness accounts, all pointing toward the involvement of Pakistan-based terror groups, mainly LeT, Jaish-e-Mohammed (JeM), and Hizbul Mujahideen.

This was not just an act of terrorism—it was a deliberate, calculated attempt to spark communal unrest in India.



#### **India's Evolving Military Policy**

For decades India's military posture oscillated between strategic restraint and limited retaliation. The sluggish mobilization model's flaws were revealed during the Kargil War in 1999, resulting in planners to develop the still-unpublished "Cold Start" doctrine, which outlines a plan for quick, shallow border thrusts that stay avoids nuclear thresholds.

However, although being feared in Islamabad, Cold Start remained politically controversial until the 2019 Balakot air attack and the 2016 Uri surgical strikes demonstrated that retaliatory invasions might garner domestic support without starting a full-scale conflict.

Operation Sindoor takes that evolution a step further. Instead of a single-night raid, it integrated persistent surveillance, standoff munitions, cyber disruption and information operations into a five-hour window of overwhelming force. A "Proactive Counter Terror Posture (PCTP)"—pre-emptive, intelligence-led, and legally articulated under Article 51 of the UN Charter's self-defence clause—is currently openly discussed by the defence ministry.

According to senior officials, upcoming military doctrine will allow future prime ministers to respond to emerging threats with a comprehensive set of calibrated options. These options will range from large-scale, division-level armoured thrusts to precision strikes using autonomous drone swarms. Enabled by a rapidly deployable network of Integrated Battle Groups (IBGs) stationed across the western front, these capabilities are designed to be operational within as little as 48 hours. This strategic posture aims to provide civilian leadership with the flexibility to tailor military responses based on the scale and nature of provocation, thereby enhancing both deterrence and readiness in a high-stakes regional security environment

#### **Strategic Objectives of Operation Sindoor**

Operation Sindoor was not merely a retaliatory strike—it was a message to the world and to terror sponsors. The operation was driven by the core objectives:

- 1. Dismantle Terror Infrastructure: The main focus was to obliterate the physical and operational bases of terror groups across Pakistan and Pakistan-Occupied Jammu & Kashmir (PoJK).
- **2. Deliver Justice:** The operation aimed to punish the perpetrators and serve as retribution for the innocent lives lost in the Pahalgam attack.
- **3. Demonstrate Military Capability:** India sought to showcase its surgical precision and advanced warfare capabilities to both adversaries and allies.
- **4. Minimize Collateral Damage:** Adhere to the evolving Indian principle of Nagrik Raksha (civilian protection), thereby retaining moral high ground and international support.

## Planning and Execution: Precision, Secrecy, and Power

Operation Sindoor was a masterclass in modern warfare planning—marked by seamless inter-agency coordination, real-time intelligence fusion, and emphasis on minimizing collateral damage.

Spearheaded by National Security Advisor Ajit Doval and Chief of Defence Staff General Anil Chauhan, the operation reflected India's new counter-terror doctrine, honed over years of asymmetric conflict experience.

The planning phase was conducted under high confidentiality within the South Block war rooms and involved top leadership from:

- Research and Analysis Wing (RAW) for human intelligence (HUMINT) and deep asset validation.
- Defence Intelligence Agency (DIA) and National Technical Research Organisation (NTRO) for satellite surveillance and signal interception.
- Indian Air Force (IAF) for air-delivery logistics and target neutralization.
- Indian Army & Artillery Command for on-ground readiness and forward deployments.
- Defence Research and Development Organisation (DRDO) to deploy electronic warfare and GPS jamming systems.

#### **Countdown to Operation Sindoor**

Post the deadly Pahalgam terror attack, a series of high-level consultantions and strategic meetings were conducted at the Prime Minister's Office to shape India's response. Some of significant meetings includes:

#### April 23, 2025 (Wednesday)

Immediately after returning from Saudi Arabia, Prime Minister Narendra Modi held an emergency high-level briefing at Palam Airport. Present at the tarmac meeting were External Affairs Minister Dr. S. Jaishankar, National Security Advisor Ajit Doval, Foreign Secretary Vikram Misri, and other senior officials.

The PM was briefed on the Pahalgam attack's confirmed links to Pakistan-based terror groups and expressed grave concern over the targeted killing of civilians, calling it "a barbaric provocation that demands a calibrated yet unflinching response." Later that day, the Cabinet Committee on Security (CCS) met to initiate strategic assessments. Over the next few days, a series of interagency war-room briefings took place, aligning intelligence inputs with military options.



After the CCS meeting, India had announced a number of measures, including downgrading diplomatic ties with Pakistan, suspension of the Indus Water Treaty and immediate shutting down of the Attari land-transit post in view of the cross-border links to the Pahalgam terror attack.

#### April 24, 2025

PM Modi chaired an **all-party meeting**, where he emphasized national unity and assured political leaders that the government was preparing a strong and proportionate response.

#### April 29, 2025

During a top-level meeting at South Block attended by the NSA, service chiefs, and defense planners. Here, Prime Minister Modi gave the Indian Armed Forces a clear "free hand" to decide the timing, scale, and method of retaliation. He stated firmly, "There will be no political interference. You have my full backing. Respond as per your judgment, with precision and purpose."



PM Narendra Modi met Defence Minister Rajnath Singh, NSA Ajit Doval, Chief of Defence Staff Gen. Anil Chauhan, Navy Chief Adm. Dinesh K. Tripathi, Air Force Chief Air Chief Marshal Amar Preet Singh and Army Chief Gen. Upendra Dwivedi during a meeting in New Delhi on April 29, 2025.

This directive effectively triggered the final operational phase of Operation Sindoor.

- 6. **Gulpur, Kotli, PoJK** LeT/JeM Advanced Training Facility
- 7. **Abbas Mosque, Kotli, PoJK** LeT/JeM Advanced Training Facility
- 8. Syedna Bilal Mosque, Muzaffarabad, PoJK
- 9. Barnala, Bhimber, PoJK

All timings were synchronized to 02:30–07:45 IST to exploit minimal civilian traffic.














#### **Neutralization of Terrorist Leaders**

Among the most critical outcomes of Operation Sindoor was the elimination of top-tier terror leadership. A precision strike on the Bahawalpur madrassa complex killed 14 members of Jaish-e-Mohammed (JeM) founder Masood Azhar's family. While Azhar himself was absent, his brother Abdul Rauf Asghar, mastermind behind Pathankot and Pulwama was reportedly injured or went underground. Simultaneous strikes neutralized LeT coordinator Qari Saeed, financier Naeem-ul-Haq, and high-value targets Yusuf Azhar, Abdul Malik Rauf, and Mudassir Ahmad, all linked to the IC-814 hijack and Pulwama blast. In total, over 100 terrorists were killed, crippling operational, financial, and leadership nodes of JeM, LeT, and Hizbul Mujahideen.

The strike, carried out using SCALP missiles from IAF Rafale jets, was timed during a high-level internal meeting.

#### **Leadership Behind the Lines**

Colonel Sofiya Qureshi played a pivotal role in mission coordination from the Army's Northern Command war room, ensuring seamless inter-agency execution. Wing Commander Vyomika Singh, leading the Rafale air strike unit, was instrumental in real-time target confirmation and aerial precision. Meanwhile, Foreign Secretary Vikram Misri led backchannel diplomatic outreach to prevent escalation and keep key global allies informed, proving that India's success was as much strategic as it was tactical.



May 8: Pakistan Responds with Artillery; India's Retaliatory Response

Just a day after the success of Operation Sindoor, tensions escalated sharply on May 8, 2025, when Pakistan initiated

unprovoked artillery shelling along several sectors of the Line of Control (LoC), including Tangdhar, Uri, and Poonch. The shelling targeted civilian infrastructure, injuring at least 11 villagers and damaging several houses and a school. The Indian Army responded immediately with counter-battery fire, but the situation intensified when Pakistan began mobilizing its short-range surface-to-air missile (SAM) units in forward areas—interpreted as a defensive move anticipating further Indian action.


This time India responded with overwhelming air and cyber superiority. Under Operation Sindoor's extended mandate, India launched a coordinated multi-domain strike targeting Pakistan's air defense systems and military radar infrastructure. Using Rudram-1 anti-radiation missiles, DRDO-developed loitering munitions, and offensive cyberwarfare teams, India neutralized forward-operating surface-to-air missile systems across Pakistan-Occupied Kashmir and penetrated deeper to destroy strategic radar installations in Lahore, a major nerve center for Pakistan's western air command.

Satellite data confirmed the destruction of three key radar stations, while jamming and spoofing tech crippled Pakistan's radar cover for over 200 km along the LoC. In just under four hours, India had blinded Pakistan's first-layer air defense shield, ensuring aerial dominance.

## May 10: Strategic Strikes on Airbases, Drone Neutralization

In a desperate and nefarious reaction Pakistan launched a coordinated drone swarm attack—reportedly using Bayraktar TB2 drones supplied by Turkey—on 13 Indian cities, including Pathankot, Bikaner, Gwalior, Amritsar, Jaipur, Jodhpur, Srinagar, and Jammu. The drones targeted defense installations, ammunition dumps, and air traffic control towers.

However, India's integrated air defense systems, including Akash missile batteries, DRDO's anti-drone systems, and electronic jammers, successfully intercepted and neutralized nearly all incoming UAVs, with no major infrastructure damage or casualties reported. The Indian Air Force confirmed the downing of 27 drones within 30 minutes, marking one of the largest aerial defense operations in Indian history.

After Pakistan's continuous escalation, the Indian Air Force carried out coordinated precision strikes on 11 Pakistani airbases, targeting UAV control centers, underground hangars, and jet fueling facilities, within just three hours. These targeted military installations include Noor Khan, Rafiqui, Murid, Sukkur, Sialkot, Pasrur, Chunian, Sargodha, Skardu, Bholari, and Jacobabad.

The attack targeted major ammunition depots and airbases such as Sargodha and Bholari, where F-16 and JF-17 fighter jets were stationed. As a result, nearly 20% of Pakistan's air force infrastructure was destroyed. Using air-launched cruise missiles and drone-synchronized targeting, India crippled Pakistan's ability to launch an organized aerial response—yet strictly limited the engagement to military infrastructure.

#### **Global and Domestic Reactions**

Operation Sindoor sent ripples across global diplomatic and strategic circles. The United Nations Security Council (UNSC) issued a strong condemnation of the Pahalgam terror attack, reaffirming every nation's inherent right to self-defense under Article 51 of the UN Charter. Countries like France, the United States, Israel, and Japan extended explicit support to India's stance, lauding the operation's precision and restraint. Even traditionally neutral nations acknowledged the legitimacy of India's response, especially after evidence of civilian-safe targeting emerged. Domestically, there was an unprecedented wave of public support. From opposition leaders to former military chiefs, voices across the spectrum praised the government and armed forces for conducting a technologically advanced, morally justified, and strategically timed operation.

#### Ceasefire: A Tactical Pause, Not a Compromise

On May 10, 2025, after days of heightened military engagement, a mutual ceasefire was agreed upon between India and Pakistan, following quiet backchannel negotiations facilitated by neutral foreign diplomats. After the heavy damage inflicted by the IAF, Pakistan's Director General of Military Operations (DGMO) called the Indian DGMO at 2;30 pm IST, requesting a cessation of hostilities along the Line of Control (LoC) and the International Border.

Later on, in a meeting chaired by NSA Ajit Doval and Defence Minister Rajnath Singh, India decided to accept

the ceasefire on three firm conditions:

- Immediate cessation of drone activity from Pakistan's side
- · No further mobilization of air assets near the LoC
- Sustained hotline-level military-to-military communication

The official announcement of the ceasefire came on May 10 from the Indian Ministry of Defence, labeling it a "tactical de-escalation to prevent further civilian harm." While it restored calm across the frontier, officials clarified it was not an agreement of peace, but a strategic pause, monitored continuously by surveillance assets and diplomatic observers.

Both the countries agreed to stop all firing and military action on land and in the air and sea with effect from 1700 hours Indian Standard Time on 10th May 2025

#### Ceasefire Violation by Pakistan

Just a couple of hours after the ceasefire, a wave of UAVs and small drones attempted to intrude into Indian civilian and military zones across Jammu, Punjab, and Rajasthan. All drones were successfully intercepted by Indian air defense systems and jamming units. In response, the Indian Armed Forces issued a strong warning and carried out localized retaliation. Additionally, field commanders have been given full operational authority to respond decisively to any future ceasefire violations.

#### **Operation with Intent: The Final Word**

Operation Sindoor will be remembered not just as a military operation, but as a watershed moment in India's modern counter-terrorism doctrine. Within days, India demonstrated its ability to detect threats, decide swiftly, and deliver justice—crippling cross-border terror camps, eliminating high-value operatives, and neutralizing retaliation plans without widening the scope of war.

The operation was precise, restrained, and deeply strategic. It showcased India's transformation into a nation that no longer waits to be attacked but preempts threats with legitimacy and accuracy. The successful defense against Pakistan's Turkish drone swarm and the decision not to escalate further despite provocations reflect a mature, disciplined military posture.

Prime Minister Modi, in his post-operation statement, called this India's "new normal"—a calibrated shift from restraint to proactive deterrence.

The operation paused not on exhaustion, but on principle, sending a message loud and clear: India will act firmly, legally, and decisively against terror, anywhere, anytime.

## A NEW CHAPTER FOR THE CAPITAL REKHA GUPTA'S FIRST 100 DAYS

After decades of the tug of war of power between AAP and Congress, Delhi CM Rekha Gupta's governance marks a significant political shift with a strong focus on infrastructure, women's safety, education reform, public health, and transparency. Her prominent landmark decisions, initiatives, and policies has sparked debates and controversies already.


But what exactly has changed in the capital under her leadership? Let's dive into a fact-rich analysis of Rekha Gupta's first 100 days in power.

#### A Historic Budget and Strategic Planning

For the fiscal year 2025-26, Chief Minister Rekha Gupta revealed a record-breaking budget of ₹1 lakh crore, an increase of 31.6% from the preceding ₹76,000 crore. The aim of the government to make long-term, sustainable development top priority has been proven by a spike in capital expenditure to ₹28,000 crore, which was more than double from the year before. The budget highlights ten focus areas, including women's welfare, youth employment, traffic decongestion, sanitation, and environment conservation. A total of ₹3,000 crore has been allocated for Delhi's 'Green Delhi Mission' alone, demonstrating CM Gupta's commitment for combating pollution and climate change.

#### **Education: Building Brighter Futures**

Under the new regime, education has been positioned as the backbone of progress. The government allocated ₹19,291 crore (19.3% of the total budget) to education. Over 1,300 deserving students from economically weaker sections (EWS) received scholarships worth ₹19 crore, within the first 100 days.



The 'Digital Delhi Schools' project has already seen tenders floated for construction of 175 computer labs and smart classrooms across government schools, with an allocated budget of ₹100 crore. Additionally, the Pt. Madan Mohan Malviya Vidya Shakti Mission has been launched with ₹21 crore to provide free coaching for the UPSC, NEET, and JEE aspirants. This aims to give underprivileged children a level playing field. Gupta has also proposed a teacher training exchange program with top universities like Delhi University and IIT-Delhi, aiming to uplift instructional quality.

## Healthcare: Accessibility, Affordability, Accountability

The spotlight has been upon healthcare reforms. The government has started equipping 13 major hospitals with more beds in order to increase the bed capacity and modern equipment with an allocation of ₹12,893 crore. To improve the last-mile delivery, more than ₹300 crore has been set earmarked for 400 Health and Wellness Centers, mostly in impoverished and slum regions. In a landmark move, Delhi implemented the Ayushman Bharat Yojana, promising ₹5 lakh annual health cover for each family. Additionally, the Delhi government has committed a top-up scheme, adding ₹5 lakh more, effectively giving a total of ₹10 lakh insurance per family annually. 8.5 lakh citizens have already signed up for this program. In 25 localities, particularly in East and North Delhi, mobile health clinics have begun to operate.

## Women's Welfare: Safety, Dignity, and Financial Freedom

Women's safety and empowerment have been the prominent themes. The Mahila Samriddhi Yojana offers ₹2,500 per month to over 10 lakh women aged 18–60 with an annual family income under ₹3 lakh. The scheme has already disbursed funds to 1.7 lakh beneficiaries. Chief Minister Rekha Gupta had announced the plan of installing 50,000 new surveillance cameras across Metro stations, markets, and sensitive neighbourhoods.

#### **Employment and Social Reforms**

The CM's office has unveiled multiple schemes for skill development and job creation. Over 25,000 job-seekers have registered with the revamped Rozgar Portal. A gig worker welfare board has been proposed to offer social security benefits like health insurance and minimum wage assurance. ₹500 crore has been assigned for youth skilling and entrepreneurship programs. Under the new Start-up Delhi policy, the government has promised zero-interest loans and subsidies for first-time entrepreneurs from marginalized backgrounds. The Delhi Skill and Innovation University is also expanding its outreach, planning 5 new campuses in Rohini, Dwarka, and Okhla.

#### Infrastructure: Roads, Transport, and Housing

Gupta's administration has launched ₹3,843 crore for the city's infrastructure renovation. This includes elevated

corridors to decongest arterial roads like Outer Ring Road and the introduction of a new Bus Rapid Transit (BRT) corridor between ISBT and Nehru Place. About 400 new electric buses are expected to be operational by the end of July 2025. The 'Atal Canteen' program, 100 subsidized meal centres across the city will provide nutritious food at ₹5 per meal. ₹100 crore has been set aside for the first phase. Pilot centres in Karol Bagh and Shahdara have already served 1.2 lakh meals collectively.

#### Environment: A Greener, Cleaner Delhi

To combat Delhi's perennial pollution crisis, Gupta's Green Delhi Mission targets 30% tree cover by 2027. In the past 100 days, over 2 lakh saplings have been planted and 45 micro forests initiated in areas like Narela, Dwarka, and Mehrauli. ₹1,200 crore has been sanctioned to upgrade sewage and waste processing plants. Air quality monitoring stations will rise from 38 to 65 by year-end. A ban on diesel generators and incentives for rooftop solar panels are under active consideration.

#### **Transparency and E-Governance**

Transparency has improved with the rollout of a Real-Time Dashboard showing ward-level budget allocation and utilization. The government has also tabled 14 pending CAG reports in the assembly, marking a break from past opacity. Citizen charters for 25 essential services like water connections, electricity, and sanitation are now legally binding under the Delhi Service Delivery Act.

#### **Conclusion: A Promising Start**

Chief Minister Rekha Gupta's first 100 days have laid the foundation for long-term transformation. While it's too early to predict outcomes, her governance style has been decisive, data-driven, and people-centric. The opposition remains critical, but even critics acknowledge the unprecedented speed of policy rollouts. Whether she can sustain this momentum is still a question, but the first 100 days have undoubtedly set a bold, reformative tone for Delhi's future.



## DRI'S NEW HEADQUARTERS

A Beacon of Modern Enforcement in India

In a landmark development reflecting India's commitment to robust economic security and modern governance, Union Finance Minister Smt. Nirmala Sitharaman inaugurated the new headquarters of the Directorate of Revenue Intelligence (DRI) in New Delhi on June 3, 2025. She was joined by the Minister of State for Finance, Shri Pankaj Chaudhary, in unveiling a facility that symbolizes a future-ready approach to economic enforcement.

Spanning a sprawling 6,200 square meters, the new DRI office complex is a blend of technological sophistication and sustainable design. It features modern digital intelligence labs, secure surveillance control rooms, collaborative zones for cross-agency interaction, and environmentally conscious installations such as solar panels and rainwater harvesting systems. This physical transformation is part of a larger institutional vision aligning with the Digital India and Atmanirbhar Bharat initiatives.

Speaking at the inauguration, Finance Minister Nirmala Sitharaman said:

DRI has been pivotal in upholding India's economic sovereignty. With this new headquarters, we are reaffirming our commitment to strengthening our enforcement architecture.

She emphasized a paradigm shift in enforcement strategy calling for dismantling entire syndicates rather than limiting operations to individual seizures.

"Enforcement should go beyond seizures. Dismantling entire smuggling syndicates and reaching the last mile is critical," she added, urging officers to adopt a comprehensive investigative framework that focuses on identifying networks, financing models, and final beneficiaries of illegal trade.

Minister of State Shri Pankaj Chaudhary underlined the importance of staying ahead of evolving threats.






Following the inaugural speeches, the dignitaries took part in a ribbon-cutting ceremony under a towering digital arch that displayed welcome messages in 20 different languages. Traditional Emirati music and dance performances welcomed global attendees in a cultural flourish that married heritage with hospitality.

The opening day was not only ceremonial—it was strategic. India, Saudi Arabia, Italy, Japan, and the United Kingdom were among the first to unveil their national pavilions, drawing large crowds. India's "Incredible India 2.0" pavilion and Saudi Arabia's NEOM Vision2030 exhibits generated early buzz, with officials conducting bilateral discussions immediately after the inauguration.

Global hotel chains like Accor, Marriott, and IHG showcased their carbon-neutral properties, while new ecoresorts from Africa and Southeast Asia presented blueprints for regenerative travel—where tourism becomes a force for environmental restoration rather than exploitation.

### Innovation in Travel Technology

The digital transformation of travel took center stage at the ATM Tech Stage, where the future of tourism was not just discussed—it was demoed. From biometric boarding gates to AI travel planners and blockchain-based luggage tracking, ATM 2025 was a launchpad for next-gen tourism solutions.

A standout innovation was the Virtual Reality Travel Pods, which allowed users to "visit" destinations like Petra, Machu Picchu, and the Taj Mahal using immersive storytelling. UAE's AI Travel Concierge also debuted, a multilingual chatbot offering personalized itineraries based on travel behavior, budget, and interests.

Startups from Singapore, Germany, and India participated in live pitch battles, judged by panels of investors and ministers.



Meanwhile, digital nomadism received a boost through solutions for smart visas, remote work travel packages, and cross-border health data tools.

Cultural preservation was also linked with tourism strategy, as nations emphasized the importance of protecting identity while modernizing hospitality.

India's participation at ATM 2025 was nothing short of grand. Unveiled by G. This year's ATM spotlighted youth and entrepreneurship with a dynamic Startup Innovation Zone. Over 200 traveltech startups participated, including promising names like:

#### • Globetrottr (India)

An AI-powered trip planner built for Gen Z, integrating real-time budget updates, local experiences, and sustainable travel suggestions.

#### • FlyChain (USA)

A blockchain-based platform for secure ticketing and fraud prevention, aiming to restore traveler trust in digital transactions.

#### NomadPass (Estonia)

A digital visa and health clearance platform designed for borderless travel, nomadic lifestyles, and post-pandemic mobility.

These entrepreneurs pitched ideas to a jury of ministers, VCs, and UNWTO officials, focusing on themes of accessibility, sustainability, and affordability.

But beneath the brutality lies a complex web of factors:

- Identity crisis and marginalization: Many young individuals recruited into terrorist ideologies often feel unseen, unheard and disconnected from the world around them. They latch on to violent movements that promise a sense of belonging and power.
- Geopolitical manipulation: Some forms of terrorism are bred not from ideology alone but from decades of international interference, failed governance systems and military invasions that have left power vacuums.

• Technological amplification: Social media and encrypted networks have made it easier for extremist ideologies to spread across borders at unprecedented speeds thereby grooming vulnerable minds within a matter of days.

At its core, terrorism today is not just about politics or religion— it's a twisted response to existential emptiness, injustice and the failure of systems that were supposed to provide meaning, fairness and identity.

## The Resurgence of Spirituality: The Soul's Rebellion

In stark contrast, the same disillusionment with political systems, materialism, and social alienation has sparked a spiritual renaissance. Millions of people, especially youth are turning inwards. They are attending yoga retreats, studying ancient philosophies, meditating and seeking out communities that offer emotional safety and purpose. The surge in interest around non-duality and mindfulness, Eastern mysticism, and indigenous wisdom systems reflects this shift.

Unlike religion, which is often tied to institutions and rigid dogmas, spirituality is deeply personal, a journey of self-inquiry, healing and reconnection with the present moment. It offers what terrorism falsely promises:

meaning, clarity, identity and transformation — but through peace and not violence.

- Digital accessibility: From YouTube satsangs to spiritual podcasts and mobile meditation apps, access to knowledge that was once esoteric is now democratized.
- Collective trauma healing: The post-pandemic world, with its isolation and uncertainty, became fertile ground for people to explore emotional healing, shadow work and spiritual growth.
- A reaction to chaos: In a world of fake news, wars, climate anxiety and rising mental illness, spirituality becomes a coping mechanism, a compass for those navigating a collapsing world.

#### The Collision Point: How Both Emerge from the Same Crisis

At first glance, terrorism and spirituality are polar opposites. But look closer—they are both responses to a crisis of meaning.

Where there is emotional emptiness, people seek answers. Some find weapons, others find silence. Some are radicalized into violence, others into compassion. The critical difference lies in how suffering is processed.

- Terrorism externalizes pain. It projects blame outward and seeks to destroy what it cannot understand.
- Spirituality internalizes pain. It seeks to understand it, transform it and dissolve the ego that fuels hatred.

This divergence points to a deeper truth: we are living in an age of psychological hunger. People are not just seeking food and shelter; they are seeking belonging, purpose, transcendence. The more disconnected our systems become from human emotional reality, the more extreme the responses.

#### The Way Forward: Integration Over Opposition

We do not solve terrorism only through intelligence agencies and counter strikes, we solve it by addressing the root causes of alienation, despair and broken identity. And we do not grow spiritually only in ashrams or through books, we grow when we engage with the pain of the world and choose love over fear.

In that answer lies the future—not just of peace or conflict, but of humanity itself.
























